
With the new site, we are also looking to

Simple things to help you

Do you travel a lot?

As the Chairman of the Practice Management Committee of the CAP, I travel a number of weekends each year. Sometimes it's hard to keep the different trips organized and know what has been done for the trip and what still needs to be done. I have developed this simple, yet very effective system to keep each of my trips well organized. Use a manila file "envelope" and create a folder for each trip, putting the date and location on the tab. Keep all trip related documents in the folder. Then store all trip folders in one location, organized by date. On the outside of each folder, when the meeting is scheduled, create a list for all the items that I need to do and put a check box next to each. For example Send in hotel reservation form. Get airfare. Rent a car. Make a reservation for auto parking at the airport. Schedule the dog sitter. Print a map of the area where the hotel is at. Send in reimbursement forms. Receive reimbursement.

By making the checklist, you are sure to get everything on the list done and not have to constantly "double check" to be sure it's completed. When you finish an item, print it off, put it in the folder and check it off of the list.

If the trip goes more than a weekend or is more complicated (i.e. hotel changes), then I draw a simple calendar on the folder and put all of the information into the dates Last, when I leave for my trip I take that folder with me and I am sure to have all of the paperwork that I need. It's also a great place to keep your reimbursement receipts during

I think that you will find this simple, yet effective system a great way of keeping your trips well organized and running smoothly.



Acetaminophen

Are your patients...or even YOU at risk for accidental or inadvertent toxicity and overdose?

Acetaminophen It's not as safe as you might think

As a physician, you know that it's a major issue that you deal with every day. Many of your patients are coming to you to look for relief of chronic or even temporary pain. And often you have patients take acetaminophen.

Why? Because it works on pain and fever, and it's generally thought to be safe. In fact, it's thought to be a safer alternative to aspirin.

But is it?

A recent article in the British Medical Journal did a systemic literature review and examined the mortality risk comparing those who took acetaminphen and those who didn't. What did they find? There was a mortality ratio of 1.9 (95% confidence interval) in overall risk, and it appears that the risk of mortality increases with increased doses. The types of problems that were identified included cardiovascular events and reduction in GFR. One issue in the US that must be considered is the increased use of combination medicines which have acetaminophen as one of the active compounds. Patients may be taking multiple different over-the-counter medications and may not realize that they are essentially taking a high dose of acetaminophen, because of the combined pound medications.

doses from the different com-This can lead to accidental overdosage and toxicity. In fact, acetaminphen toxicity has replaced viral hepatitis as the most common cause of acute hepatic failure and the second most common cause of liver failure requiring liver transplantation. In Europe, it is the cause for 20% of transplants for acute liver failure. It's should always be considered an ESSENTIAL practice to go over ALL of the medications that a patient is taking, including over the counter medicines and supplements, before prescribing any medication, either new or ongoing. And it's also good practice to keep acetaminphen toxicity in your differential diagnosis for patients with unexplained GI symptoms during times when they may have accidentally

use of multiple combination medications..such as the cold and flu season.

The amount of information that is being published on the internet is astounding. But there are some places where there is a great collection of interesting information for physicians. Medscape is one of those places.

By going to Medscape.com you can search for a variety of different items, from practice issues, practice patterns, business of medicine, advocacy and other items. In addition, Medscape publishes a number of reports that are available for review. It's easy to scroll through them and pick what you might find interesting. If you use the search box at www.Medscape. com and enter "reports", you will have nearly 70,000 different items to choose from. These items include such items as physician compensation, business of medicine, to Angelina Jolie's impact on breast and ovarian prophylactic removals. It's all interesting...and from a great source.

Practice review using cash flow statements

Accounting 101

Last month, we talked about the balance sheet; what it represents and some important basic items that you can get from it. This month, let's briefly touch on the cash flow state-

As opposed to the balance sheet, which is a "snapshot" at a given point in time, the cash flow statement is more like a movie. It encompasses all of the financial transactions that have occurred over a period of time. You can look at a day, week, month, year or longer period of time. You choose. But typically looking at "guarters" (three month segments) or annually is common. By

using these longer intervals of time, you can better identify trends and differences from other time periods. Financial events, including bills

or other liabilities paid out, and income from all sources that have been entered into the accounting program (i.e. "posted") during that time period will be included. Although some businesses use an "accrual" method of accounting, most medical practices function on a "cash" basis.

When you print out a cash flow statement, you will see all of your expenses, payments, deposits and other financial items that occurred during that time period.

Having cash flow statements from various time periods, you can compare various categories of liabilities (costs) and credits (income). Comparing between time periods can help you see changes...either up or down, and help identify components of your business that are increasing or decreasing in costs, or income. Identifying these trends can help you better focus on those components of your business

where you can take action and generate a greater impact. Remember...knowledge is power. And the cash flow statement helps you be more knowledgable about your practice finances.

This Month's Q&A Technology Tips

Q: What the heck is an "app"?

A: You hear about "app"s all the time. Apps for everything you can think of.

Well, it's really just an abbreviation for an "application". And yes, there are gazillions of them.

But an app is really just a small program. No different than Word or Excel, they provide a function. But unlike the big "programs" that we use, "app"s are small and very focused, usually only doing a handful of functions.

Apps are most commonly made for your smart phone or tablet, but there are also apps that you can download to your computer. Most apps are specifically designed for a single type of hardware. iPhone and Android apps won't work on each other's hardware, but app makers often have different versions for the different machines, so an app is often

available for both phone types.

Apps are available through various sites (like the Apple Store), or in some cases are only available from the app author on their site. Some are free, but other are not.

Regardless, remember that these are programs that run on your system, and if they contain a virus...they can harm your phone, tablet or computer. So be sure that you only download these programs from a reputable source, such as a genuine app store or a trusted third party supplier.
